2. Presidents Report

- Rent was paid in full for February
- Waived [eeers] (~\$9000)
- Softball player fee cost till end of the year: \$200/player
 - i. Rostered players from Feb:
 - 16U 10 players
 - 14U 6 players
 - 12U 10 players
- Baseball player fee (12U Salazar) - \$100/player
- TAXES: Requesting previous 2024 spreadsheets for taxes (2024 crab feed); already filed for extension till October (give time to collect, and complete taxes)
- PG&E – Possible contributions to high electricity cost:
 - i. Air conditioning unit is off possibly pulling power
 - ii. Other contributions pulling power: (egress lights – breaker turned off #11; vending machine) turn off all lights in bathroom and cleaning)
 - iii. Fridge stays plug in
 - iv. See lower electricity for April bill
- DNO insurance - not buying it yet; waiting for full rosters for teams

 - Heather – will lend her Square scanner/assist with charging; MC can assist w/teaching or signing into SWAT account for charges with Square.
 - Dessert baskets will be part of live auction
 - Players/parents to be there at 1pm on Saturday for setting up
 - BC requested more help to move items from facility for crab feed; (meet Saturday morning – 12:15pm at facility); MC and Jason will assist BC for transporting items
 - Tickets will be made for
